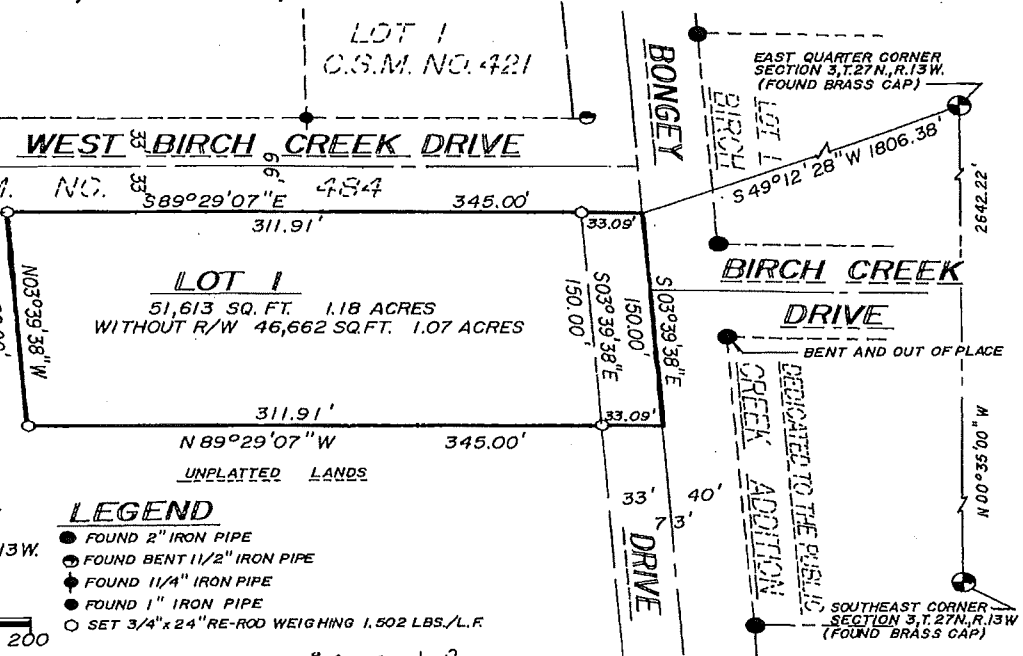
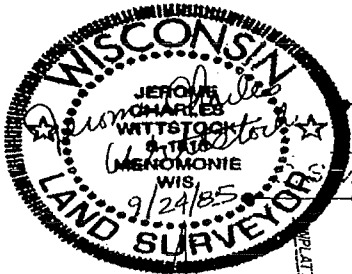


**CERTIFIED SURVEY MAP NO. 551**
