


125 miles Northeast of Dallas/Fort Worth Airport

Lush landscaping surrounds house. Home also features security, smoke & fire system, stereo speakers, satellite & hi-speed internet systems, and two central vacuum systems.

Oversized 2½ car garage with large outside parking and turnaround areas. ¼ mile private driveway. Barn, near home, provides additional parking and storage.

Gunite pool and "coolcrete" decking with terracotta floor tile on covered patio and walkways. Inside full "pool" bath with shower and deep whirlpool soaking tub.

Beautiful Acme brick house. Spacious sunrooms on north and south side of home. Two all brick wood-burning fireplaces. First floor master suite and guest bedroom with three full baths and powder bath. Three bedrooms and two full baths upstairs.

Maintenance-free wood interior (aluminum-clad exterior) Pella windows and doors. New (March 2011) four-zone American Standard 20SEER heating and cooling systems (10yr full warranty). Cellulose 12" attic & super wall cellulose insulation with TUFF-R Cellotex exterior foamboard & aluminum sheathing provide maximum utility efficiency.









Beautiful 71 acre ranch with a 12 acre livestock/fishing lake and smaller pond. Pastures are bordered by mature native oak trees.

Foundation plantings are pink, white and red azaleas. Additional landscaping accents include Bald Cypress trees, Japanese Red Maples, Dogwoods, Red Oaks, Post Oaks, Shumard Red Oaks, Burr and Live Oaks, Pines, Hollies, Chinese Pistachio and flowering Bradford Pears.

Louisiana blue, purple, white and yellow Iris grow on the banks of the small pond, as well as in the koi pond next to the raised deck in the back yard. Daylilies, daffodils, and seasonal blooms are plentiful.

J-shaped home layout surrounds a large pool accessible thru high efficiency Pella sliding doors with "between glass" e-type blinds.















House is privately situated ¼ mile off County Road 44850 in Blossom, TX.



Situated about 10½ miles North 83 Deg. East of the City of Paris, County of Lamar, and State of Texas, a part of the Justin Ferry Survey #334, and being a 71 acre tract of land conveyed D.D. McCaskill by deed recorded in Vol. 634, Page 948, of the Deed Records of said County and State.

Beginning at an iron pin for corner at the present Northeast corner of said 71 acre tract

Thence North 88 Deg. 42 Min. West along an old row of posts and fence a distance of 1471.6 ft. to a tree for corner at the Northwest corner of said 71 acre tract;

Thence along an old row of posts and fence along the West Boundary Line of said 71 acre tract as follows: South O Deg. 24 Min. East 1198.4 ft. to a post; South O Deg. 43 Min. East 1031.2 ft. to an iron pin for corner at the Southwest corner of same;

Thence North 88 Deg. 38 Min. East along the South Boundary Line of said Ferry Survey a distance of 1462.9 ft. to a post for corner at the present Southeast corner of said 71 acre tract:

Thence along the West Boundary Line of a County Road as follows: North 2 Deg. 31 Min. West 289.4 ft. to an iron pin; North a distance of 1872 ft. to the place of beginning and containing 73.725 acres of land.
