WHEREAS, by final decree of the 35th Judicial District Court of Mills County, Texas, in Cause No. 4097, In Re: The Adjudication of Water Rights in the Upper Leon River Segment of the Brazos River Basin dated September 8, 1983, a right was recognized under Permit 2637B authorizing Clifton D. Geye and wife, Frankie Geye, to appropriate waters of the State of Texas as set forth below;

WHEREAS, by final decree of the 220th Judicial District Court of Comanche County, Texas, in Cause No. 16,062, In Re: Wayne D. Gilliam, et ux, vs Don Chester, et al, dated February 13, 1985, the amount of water the owners were authorized to divert and use per annum, under Permit 2637B as recognized in the adjudication of water rights in the Upper Leon River Segment of the Brazos River Basin, was reduced by 8.36 acre-feet;

NOW, THEREFORE, this certificate of adjudication to appropriate waters of the State of Texas in the Brazos River Basin is issued to Clifton D. Geye and wife, Frankie Geye, subject to the following terms and conditions:

1. IMPOUNDMENT

Owners are authorized to share in the maintenance of an existing dam and reservoir on Martins Creek and impound therein not to exceed 960 acre-feet of water. The dam is located in the Enos Cooper Survey, Abstract 136, Comanche County, Texas. The dam and reservoir are also authorized under Certificates of Adjudication 12-3586, 12-3587, 12-3588 and 12-3589.

2. USE

- A. Owners are authorized to divert and use not to exceed 321.64 acre-feet of water per annum from the aforesaid reservoir on Martins Creek to irrigate a maximum of 165 acres of land out of a 300.4 acre tract located in the H. C. Brigance Survey, Abstract 1119; the Enos Cooper Survey, Abstract 136 and the W. T. Jones Survey, Abstract 1873, Comanche County, Texas, said 300.4 acre tract being described as follows:
 - (1) BEGINNING at a point that bears West, 786.25 varas from the northeast corner of the H. C. Brigance Survey, Abstract 1119;
 - (2) THENCE South, 114.50 varas to a corner;
 - (3) THENCE S 84°E, 100.00 varas to a point;
 - (4) THENCE S 78°30'E, 228.50 varas to a corner;
 - (5) THENCE South, 683.00 varas to a corner;
 - (6) THENCE East, 403.50 varas to a corner;
 - (7) THENCE North, 436.00 varas to a corner;
 - (8) THENCE East, 1068.00 varas to a corner;

- (9) THENCE North, 420.00 varas to a corner in the northeast corner of W. J. Jones Survey Abstract 1873;
- (10) THENCE West, 360.50 varas approximately to a corner;
- (11) THENCE North, 570.25 varas to a corner;
- (12) THENCE West, 1106.00 varas to a corner;
- (13) THENCE North, 167.25 varas approximately to a corner;
- (14) THENCE West, 387.80 varas approximately to the northwest corner of this tract;
- (15) THENCE South, 728.90 varas approximately to the place of beginning.
- B. Owners are authorized to use part of the 330 acre-feet of water per annum to irrigate an additional 65 acres of land, under a lease agreement, on land owned by Ronnie Martin, located in the north one-half of the J. B. Taylor Survey, Abstract 1431, Comanche County, Texas.
- C. Owners are also authorized to use the impounded waters for recreation purposes.

3. DIVERSION

- A. Location: At the perimeter of the aforesaid reservoir.
- B. Maximum rate: 2.00 cfs (900 gpm).

4. PRIORITY

The time priority of owners' right is October 13, 1970.

5. SPECIAL CONDITIONS

- A. Owners shall maintain a suitable outlet in the aforesaid dam authorized herein to allow the free passage of water that owners are not entitled to divert or impound.
- B. Authorization to irrigate land in the J. B. Taylor Survey, Abstract 1431, shall expire and become null and void upon termination of the lease agreement, dated December 30, 1977, under this certificate is attached to the leased land located in the J. B. Taylor Survey, Abstract 1431, Comanche County, Texas.

The locations of pertinent features related to this certificate are shown on Page 8 of the Upper Leon River Segment Certificates of Adjudication Maps, copies of which are located in the offices of the Texas Department of Water Resources, Austin, Texas and the Office of the County Clerk.

This certificate of adjudication is issued subject to all terms, conditions and provisions in the final decree of the 35th Judicial District Court of Mills County, Texas, in Cause No. 4097, In Re: The Adjudication of Water Rights in the Upper Leon River Segment of the Brazos River Basin, dated September 8, 1983, and supersedes all rights of the owner asserted in that cause.

This certificate of adjudication is issued subject to senior and superior water rights in the Brazos River Basin.

This certificate of adjudication is issued subject to the Rules of the Texas Department of Water Resources and its continuing right of supervision of State water resources consistent with the public policy of the State as set forth in the Texas Water Code.

This water right is appurtenant to and is an undivided part of the above-described land within which irrigation is authorized. A transfer of any portion of the land described includes, unless otherwise specified, a proportionate amount of the water right owned by the owner or seller at the time of the transaction.




